PLEASE READ FIRST - IMPORTANT!

If the Shareholder is a client with Hatfield Oak already the Client Number must be used instead of shareholder's name.
If the shareholder is NOT a client with Hatfield Oak and is an Individual, he/she must submit a Personal Information Form (211A).
If the shareholder is NOT a client with Hatfield Oak and is a Company, the company must submit a Corporate Information Form (215A).
If shareholder owns a percentage (%) of shares this will be rounded to the nearest whole share in the Share Register. The total number of shares can never exceed more than 100% of the company's shares. Share Registration fees applies if more than 10 shareholders or upon changes to the Share Register. Share Issuance fees applies if shares must be physically printed (issued).

If issued Named shares are redistributed/sold to others new shares must be issued, and the Share Register updated accordingly and the new shareholder must provide shareholder information. If issued Bearer's shares are redistributed/sold, new shares will not be issued, but the Share Register must be updated and the new shareholder must provide shareholder information. The Share Register is only available to the Board of the Company, not the individual shareholders, unless the Board decides otherwise.
